# School Holiday Program January 2008

## Important information for parents/guardians

1. Children must meet the age requirements of the sessions provided for their safety and enjoyment.

10-14 yrs - children must be aged 10 as at the 1/1/2008.

7 to 9 yrs - children must be aged 7 as at the 1/1/2008

5 to 6 yrs - children must be aged 5 as at the 1/1/2008

2. For safety reasons children **MUST** wear appropriate clothing - closed-in shoes (no thongs or sandals), warm weather or waterproof clothing as needed.

**Children WITHOUT appropriate shoes and clothing WILL NOT be admitted.**

3. Cost is \$15 for Mini & Junior programs, \$20 for Senior programs and \$30 for any program for non-members (includes Paw Print membership). Payment is required in advance via cash, credit card or cheque (payable to the RSPCA). **BOOKINGS WILL NOT BE HELD WITHOUT PAYMENT**

4. Holiday program activities are conducted by RSPCA Education Officers and staff.

The RSPCA reserves the right to remove any child from an event and contact parents where deemed necessary, ask for identification when picking up a child from a session and cancel an activity when unavoidable.
