

IMPORTANT INFORMATION FOR PARENTS/GUARDIANS

1. Children must meet the age requirements (of the sessions provided) for their safety and enjoyment.

10 to 14 yrs - children must be aged 10 as at 1/1/2009

7 to 9 yrs - children must be aged 7 as at 1/1/2009

5 to 6 yrs - children must be aged 5 as at 1/1/2009

2. For safety reasons children **MUST** wear appropriate clothing—closed-in shoes (no thongs or sandals), waterproof or warm weather clothing (eg. wide-brimmed hats) as needed. **Children WITHOUT appropriate shoes and clothing WILL NOT be admitted.**

3. Cost is \$15 for Mini & Junior programs, \$20 for Senior programs and \$30 for any program for non-members (includes 12 months Paw Prints membership). Payment is required in advance via cash, credit card or cheque (payable to the RSPCA). **BOOKINGS WILL NOT BE CONFIRMED WITHOUT PAYMENT**

4. Holiday program activities are conducted by RSPCA Education Officers and staff. The RSPCA reserves the right to remove any child from a program, contact parents where deemed necessary, ask for identification when picking up a child from a session and cancel an activity when unavoidable.
